

ヴァンガードの動画投稿についてのガイドライン

Guideline for using the Contents of “Cardfight!! Vanguard”

The copyrights, trademarks, and the other intellectual properties of images, designs and the other contents (hereafter referred to as “Contents”) used or utilized in the trading card game named “Cardfight!! Vanguard” (hereafter referred to as “Vanguard”), published by Bushiroad Inc. (hereafter referred to as) “Bushiroad”), are owned by Bushiroad and/or its licensors.

Basically, any users of Vanguard (hereafter referred to as “Users”) shall not use (including but not limited to duplicate, copy, upload and deliver) the Contents without prior written consent of Bushiroad.

Notwithstanding the above, Bushiroad will not enforce its intellectual property rights to the posting of the Contents of Vanguard (including commentary videos) on a video-sharing or photo-sharing website by Users as long as the following guidelines are adhered to.

- Users shall use the Contents of Vanguard only for non-commercial purposes. Notwithstanding the above, Users may use the monetization program officially provided by the video-sharing or photo-sharing website (so-called partner program or creator program).
- Users shall use the Contents of Vanguard in accordance with applicable laws and regulations, and public policy.
- Users shall use the Contents of Vanguard while displaying reasonable sized copyright notice (as listed below) on the appropriate position of the website, paper and/or image containing the Contents of Vanguard.

- Users shall use the Contents of Vanguard without using a third party’s animation, characters, music, voices and other intellectual property.
- Users shall NOT use the Contents of Vanguard with violating this guideline, rules and/or regulations provided and/or designated by Bushiroad.

- Users shall NOT post any Contents of Vanguard that damages the reputation of Bushiroad and/or third party, and/or the Contents, characters or products of Vanguard.
- Users shall NOT dub or add sounds to character or unit voices, nor use speech bubbles, speech balloons, etc. to represent their speech.
- Users shall NOT use the card products and/or card games illustrated, published, produced and/or manufactured by a third party or Users (including but not limited to so-called proxy cards) in the posting of Contents of Vanguard.
- Users shall NOT use the Contents of Vanguard for misleading purposes such as supporting or endorsing particular individuals, political parties, religious groups, etc.

Bushiroad will keep and hold its intellectual property rights on the Contents of Vanguard and will enforce its rights to Users breaching and/or violating this guideline. In case Bushiroad ask you to delete a specific posting of the Contents of Vanguard, you shall delete such Contents promptly.

Bushiroad will give no guarantee to any Users for using (including but not limited to duplicating, copying, uploading and delivering) the Contents, including non-infringement of any valid right of a third party.

Bushiroad shall not be responsible for any dispute or trouble User may have with a third party by using the Contents of Vanguard.
